### **ORDER**

In G.O. (p) No. 285/86/Fin. dated 3-4-1986 Government granted another chance for excercising re-option for postponement of service based Higher Grade/Non- Cadre promotion to those employees who got such promotions during 1-7-1983 (date of effect of general Pay Revision) to 16-9-1985 (date of issue of pay revision orders) subject to the following conditions:-

- (i) Excess pay drawn should be refunded in lump
- (ii) Monetary benefits arising out of the fixation of pay in the revised scales of pay consequent on the re-option will be allowed with effect from 1-4-1985 consistent with para 6 of G.O. (P) No. 515/Fin. dated 16-9-1985.
- (iii) Revised option should be exercised within a period of three months from the date of order.
- 2 In the Government Order third cited Government again granted another chance for re-option for postponement of service based Higher Grade/non –cadre promotions to those employees who got such promotions during the period between 1-7-1983 and 16-9-1985 subject to the first two conditions specified in the earlier Government Order dated 3-4-1986. Time limit allowed for exercising option in pursuance of the Government Order third cited expired on 31-7-1987.
- 3 Government have received several petitions stating that G O(P) No. 421/87/Fin.dated 6/5/1987 reached many offices only after the expiry of the time limit prescribed for exercising option which resulted in the denial of chance for re-option for higher grade/non-cadre for certain employees . It has therefore been represented to Government that one more chance to exercise re-option under the above Government Order may be allowed.
- 4 Government have examined the question in detail and are pleased to grant one more chance for re option for postponement of service based higher grade/non cadre promotions to those employees who have got such promotions during the period between 1-7-1983 and 16-9-1985 subject to the first two conditions specified in the earlier

Government Order dated 3-4-31986. The revised option under this order can be exercised till 31-1-1988
