PAY REVISION 1983- TIME BOUND HIGHER GRADE PROMOTION SCHEME-FIXATION OF HIGHER GRADE FOR ATTENDERS – ORDERS ISSUED.

ORDER

Attenders are a common category. Their entry grade is Grade II Attender in the scale of pay of Rs. 575-900. They are eligible for ratio –based promotion to the first grade in the ratio of 1:2 between Grade I and grade II.

- 2. Under the liberalized time bound higher grade promotion scheme sanctioned in para 10 of General Pay Revision Order cited, employees in the revised scales of pay ranging from Rs. 550-800 to Rs. 1150-2250 will be allowed promotion to the first higher grade on completion of 10 years of service and a second higher grade after either 10 years of service in the first higher grade or a total service of 20 years in the two grades, whichever is earlier. The higher grade to be sanctioned for a category in the normal course, will be the scale of pay of the next promotion post in the direct line of promotion subject to the requirement of qualification. Under the above scheme, Attenders Grade II will be eligible for the first higher grade on completion of 10 years of service as Attender in the scale of pay Rs. 600-950 which is the scale of pay of their promotion post.
- 3. At tenders are also eligible for a second higher grade for 20 years of service under the scheme of time bound higher grade promotion. Since they do not have any second level of promotion in the direct line of promotion, the scale of pay of the second higher grade has to be fixed by Government According to the norms now followed for fixation of higher grades in cases where there are no promotion posts, higher grade is allowed in the next higher scale of pay in the list of standard scales of pay. The next higher scale of pay for Rs. 600-950 in the list of standard scales of pay is Rs. 640-1000. Therefore Government Are pleased to fix Rs. 640-1000 as the scale of pay for the second higher grade for Attenders on completion of 20 years of service.
