CIRCULAR

PROVIDENT FUND-SUBSCRIPTION TO STATE PROVIDENT
FUND BY THE ERSTWHILE CONTINGENT EMPLOYEES
BEFORE ADMISSION TO STATE PROVIDENT
FUND-PROCEDURE-ORDERED

In G.O. No. (P) 53/58/Fin. Dated 11 the March, 1958 it has, inter alia, been ordered that the Contingent Employees absorbed in the regular establishment will not be allowed to contribute to the contributory Provident Fund Scheme any further. It has also been ordered that they may join the State Provident Fund.

It has now been brought to the notice of Government that though all the Heads of Departments were requested by the Comptroller, Kerala to forward to the Audit office the applications of the Contingent Employees who have been absorbed in the regular establishment with effect from 2nd September, 1957 and who intend joining State Provident Fund for admitting these employees to the State Provident Fund and assigning account numbers in the State Provident Fund Accounts, many have not done this. It is also reported that subscriptions to the State Provident Fund are being recovered from Contingent Employees who have not formally applied for and been admitted to the State Provident Fund Scheme, quoting the Contingent to the state Provident Fund Account Numbers. The deductions received in the Audit Office are kept under suspense pending allocation of the credits to the concerned subscribers.

As the amounts under suspense are swelling and have to be cleared by crediting them to the respective subscriber's Provident Fund Accounts, all the Heads of Departments are requested to take immediate action to get these subscribers admitted to the State Provident Fund and to follow the correct procedure for deducting recoveries from the subscribers to the State Provident Fund.
