ORDER

It is laid down in Rule 13 (Viii) (I) (C) of the General Provident Fund (Cochin) Rules that when a subscriber repays to the Fund with interest the whole of the amount withdrawn from the found for payments of premia on a Life Insurance Policy the Comptroller shall on behalf of the Governor reassign the policy to the subscriber or to the subscriber and the joint assured, as the case may be, and make it over to the subscriber together with a signed notice of reassignment addressed to the Insurance company. There is a similar provision in Rule 22(1) (d) (i) of the General Provident Fund Rules (Madras) and also in the General Provident Fund (Central) Rules.

The Government of India have in their O. M. read as first paper above, stated that a question has been raised whether in such cases the subscriber should repay the amount in a lump sum or in installments and whether in case the amount is allowed to be repaid in installments, the number of installments should be fixed by the competent authority or left to the discretion of the subscriber and that it has been decided that the amount may be repaid in convenient installments, the number of installments being settled between the subscriber and the Accounts Officer. However in such cases the policy will be reassigned by the Accounts Officer only after the repayment of the amount with interest

Is completed.

The Comptroller who was consulted on the desirability of introducing such a provision in the relevant Provident Fund Rules has agreed to the proposal.

Accordingly Government are pleased to order that a note will be introduced under the relevant Rules in the General Provident Fund (Cochin) and General Provident Fund (Madras) Rules on the basis of the decision taken by the Government of India in the matter.
