As per above Government Orders, education allowance @ RS. 100 per month was sanctioned to the State Government Employees/Part Time contingent employees for the education of their physically handicapped/ mentally retarded children subject to certain conditions as stipulated in the G.O. dated 25-11-1998 . Subsequently, the Accountant General in his letter referred to above has sought clarifications as to whether the above allowance is admissible to those State Government Employees whose handicapped children are studying in normal school but are not under going training of any sort with relation to their disability and parents of children who are studying in institutions like school for deaf and dumb.

It is therefore clarified that the above education allowance is not admissible to State Government employed parents whose handicapped children are studying in normal schools. However , State Government employed parents whose children are studying in Special Institutions like deaf and dumb shall be eligible for the above allowance.

If the education allowance is sanctioned incorrectly prior to this order, that will not be recovered from the employees.
