ORDER

In the G.O read as first paper above, it has. Inter alia. Been ordered that the personnel allotted from Madras State to Kerala State consequent on the reorganization of states who were governed by the Madras contributory Provident Fund-Pension-Insurance Rules in the matter of their retirement benefits and who had opted be governed by the K.S.R should join the S.P.F (Travancore) or take a Policy in the State Life Insurance (Official Branch).

- 2. In the G.O. read as second paper above, it has been clarified that such of those approved probationers who were members of the C.P.P.F (Madras) also should join the S.P.F. or take a policy in the State Life Insurance (Official Branch) compulsorily, after their option to the K.S.R
- 3. Now the Director of Technical Education has requested orders as to the date from which the Government servants who have been declared to have satisfactorily completed their probation are to be enrolled compulsorily in the S.P.F.

4. Government have considered the question in detail and are pleased to order that such of those approved probationers who have not joined the C.P.P.F (Madras) scheme but opted for the K.S.R should be admitted to the S.P.F compulsorily from the date of their confirmation.
