ORDER

In the notification read above, the IFS (Fixation of Cadre Strength) Regulations, 1966, were amended in respect of Kerala Cadre. Consequent on this review, certain additional posts have been encadred and certain existing posts in the cadre have been omitted Therefore, it has become necessary to accommodate Officers against the newly encadred posts and also against ex-cadre posts created for the purpose. In such circumstances, the following orders are issued.

1. The ex-cadre post of Chief Conservator of Forests (Vigilance continuance of which was sanctioned as per G.O. (Rt) No. 3789/99 GAD 13.5.1999 is re-designated as Chief Conservator of Forest (Development)
2. The following ex-cadre posts are created for a period of one year from 2.11.1999 with equation under Rule 9 of the JFS (Pay) Rule as noted against each:
