Sub:-Estt:- Redistribution of the posts of Personal Assistants and Confidential Assistants-Orders Issued.

There are 3 posts of Personal Assistants and 39 posts of Confidential Assistants in the department. They stood distributed as shown in Annexure-A. As per decision taken in the CCFs Council dated 21.10.2000, services of CAs have to be made available to all the Officers down to the level of Conservators. No posts of CAs have been sanctioned to CCF(South)-Kollam, CF(World Bank Project)-Project Administration, Thiruvananthapuram and CF (Bio-diversity Cell)-Thiruvananthapuram. As per the latest order revising the strength of the Kerala Cadre of IFS, the posts of DCF (Industries) and Forest Utilization Officer have been upgraded or redesignated. Hence the posts of CAs which are now attached to DCF(Industries) and FUO can be diverted for allocation to CCF(South) and CF (WBP). At Present there is only one Deputy Conservator in Social Forestry Wing and Chief Conservator of Forests (SF) has suggested that this post can be re-allotted. Hence the post of CA attached to DCF (SF)-II can also be diverted for allotment to CF(Bio-diversity Cell). The above proposals been approved by the Principal Chief Conservator of Forests (D&P) and Principal Chief Conservator of Forests. Accordingly the 3 posts of Pas and 39 posts of Confidential Assistants are redistributed as follows; till posts of Personal Assistants/Confidential Assistants are created by Government for the newly created posts of Chief Conservators of Forests, Conservators of Forests & Deputy Conservators of Forests.
